

Submission of abstracts

Abstracts should be about 2 pages (800 to 1000 words) in length and contain the following information.

- Title
- A clear statement of the research question
- Methodology adopted
- Outline of (expected) results
- Bibliographical notes (up to 6 key references used in the paper)

Please submit your abstract in PDF format via EasyChair. All abstracts will be subject to double-blind peer review.

Publication opportunities


The conference organizers intend to publish special issues of *Telecommunications Policy* and *Digital Business* based on the papers presented at the 24th Biennial Conference of the ITS.
